

Arts Quest Theatre School in conjunction with Idaho Summer Repertory

Enrollment Agreement

Parents and students are required to sign this agreement and return it, along with the Medical Release to Idaho Summer Repertory Theatre School, 921 S. 8th Ave., Stop 8006, Pocatello, Idaho 83209-8006 **with the registration form.**

1. **Payment:** The Parent signing this agreement agrees to pay the required tuition.
2. **Withdrawal:** The withdrawal, suspension, or expulsion of the student after May 3, 2010 shall not relieve the Parent of any obligations under this agreement, including the obligation to pay tuition.
3. **Enrollment:** While reasonable consideration will be made to accommodate the needs of each student, Idaho Summer Repertory Theatre School reserves the right to reconsider enrollment or send a student home should issues require support beyond the capabilities of Idaho Summer Repertory's staff.
4. **Release:** The Parent agrees to and does hereby release Idaho Summer Repertory Theatre School from any and all liability for any injury or damages suffered by the student during his/her camp experience, including participation in any athletic or recreational activity, in the absence of any gross negligence by Idaho Summer Repertory or its staff.
5. **Damages:** The Parent assumes responsibility for any damage to Idaho Summer Repertory property, or property used by Idaho Summer Repertory, caused by the student or chargeable to him/her under the rules/regulations of the school. The Parent acknowledges and agrees that Idaho Summer Repertory shall have no responsibility whatsoever for any damage or loss sustained by the Student to his/her personal property while it is located on Idaho Summer Repertory premises or is accompanying the Student on any Idaho Summer Repertory trip.
6. The agreement may not be modified orally. It may only be modified in writing signed by both parties.
7. Consent is hereby given for the Student to participate in authorized Idaho Summer Repertory Theatre School concerts, radio, television and transcribed broadcasts, distance learning videoconferences, tours, and other on and off campus performance activities without compensation paid to Student. Our consent is also given for full and unrestricted use of Student's image and/or voice, without compensation, in photographs, videotapes and sound recordings, created for authorized Idaho Summer Repertory Theatre School use promotions, videotape and film projects, broadcasts and printed materials such as newspapers, magazines, books, brochures, catalogs, the Idaho Summer Repertory Theatre website on the World Wide Web, audiotapes, CD's, CD-rom's, and other authorized educational activities by Idaho Summer Repertory Theatre School.

This contract is being entered into in the State of Idaho and shall be interpreted under the laws of the State of Idaho. It is further agreed that any litigation which either Idaho Summer Repertory or the student, parent or guardian may bring against the other may only be brought in a court located in Bannock County, Idaho.
