

Idaho State University Electronic Funds Transfer Information

Idaho State University (ISU) is pleased to accept an electronic funds transfer from you. These funds will be credited to the total tuition, fees, and other charges, if any, that you will owe ISU upon your registration. In order for ISU to receive your funds and credit them to your account with us, please be sure to provide all of the information requested. By sending funds electronically, you are not opening a bank account in the United States. You are depositing funds into Idaho State University's bank account and any deposits made will not accrue interest. We recommend that you transfer about \$9,075.00. **ANY TRANSFER OF MORE THAN \$9,075.00 WILL NOT BE ACCEPTED BY OUR BANK. STUDENTS WHO DO NOT USE THIS EASY OPTION TO PAY THEIR FEES, AND WHOSE FEES ARE NOT PAID BY THE OFFICIAL DISENROLLMENT DAY, WILL HAVE THEIR CLASSES DROPPED AND WILL BE OUT OF STATUS WITH U.S. IMMIGRATION.**

Please note the processing fee of \$15.00 will apply to all incoming transactions.

In the event that you are unable to attend ISU, approximately twenty working days after classes have begun, you will be assessed a processing fee of \$15.00 and the balance of your funds will be electronically sent back to the account from which we received them.
