 - i. The name of the policy

 - 3. Title the council likes is "Faculty Suspension or Dismissal for Adequate Cause"

 - 1. Provost
 - 2. Dean or Unit Directors
 - 3. Vice President
 - 4. Faculty Member: Subject to Recommendation for Dismissal or Suspension
 - 5. The Respondent/Provost/Dean? 9To be determined
- iv. The general responsibilities of the different actors/stakeholders
 - 1. Provide reasoning/evidence justifying adequate cause for dismissal/suspension
 - 2. Timely notification and time stamps for each step of the process
 - 3. All aspects in writing (Certified Mail?)
- v. The requirements and/or recommendations for informal resolution
 - 1. Required
 - 2. Notice must be given and opportunity to respond must be given
 - 3. Given opportunity to meet but meeting not necessarily required
 - 4. Opportunity to resign during this stage. (doesn't need to be formally written in)
 - 5. Opportunity to ask question about this stage
- vi. The origination of the appeals process
 - 1. Informal
 - a. Whoever is wanting to make the recommendation starts the notification process
 - 2. Formal
 - a. Refer to 4041
 - i. Will be revisited after we see what happens with ISUPP 4041

 - 1. Distribution of Representation
 - a. 2 Faculty per college (KDHS has 2 Colleges: Pharmacy and College of Health)
 - b. Representatives based on # of Faculty?
 - 2. Who are eligible
 - a. Tenured, Non-Tenure-Track, Tenure-Track?
 - 3. How to Get on Panel
 - a. Admin Appointed?
 - b. Elected?
 - c. Faculty Senate Appointed?
 - d. Drawn by Lot of Tenured Faculty Senate Members
 - 4. Size of Committee
 - a. 4-5 (Same as Grievance?)
 - 5. Terms?
 - a. Time Limits?
 - b. Staggered Terms?

- ix. Burden of proof language
- x. The nature of the report generated by the grievance committee
