- b. Periodic Performance Review of Tenured Faculty Policy
 - i. Downing presented the policy as she and Forest have produced it up to this point and asked for feedback from the council on what constitutes an "administrator" in order to define who can serve on the committee
 - 1. After council discussion, Barrott charged Downing and Forest to continue working on the policy based on suggestions made by council members during the discussion
 - a. This includes distinctively defining "administrator"

- c. Academic Freedom Policy
 - i. Two questions
 - 1. Whether this policy should address the issues facing students/public
 - a. Should the policy include rights as a private citizen
 - 2. What to do if a student has a moral requirement for or against a course requirement.
 - a. Do we want to address this question in this policy or leave it for student policies
 - i. Council decided to remove this section of the policy and to not address the students in this policy
 - ii. This will be brought to the next FPPC meeting for a final vote
