LEARNING GOALS AND OUTCOMES FOR SOWK 4460 Grief and Loss

Course Description

This course will prepare students to work with clients experiencing grief and loss issues stemming from a variety of loss experiences including death, physical health changes, trauma, and life transitions. The philosophical, cultural, medical, psychological, and spiritual aspects of grieving and loss will be covered. The grief process and factors to consider in working with children, adolescents, and adults will be covered as well as assessment of complicated grief reactions.
