 Annual Evaluation/5 Year PPR (10 minutes) 2nd Year Annual Evaluations are due November 14, 2022 to Academic Affairs. TMS system has been open for all faculty for them to enter their evaluations. Instructions will be shared at the Associate Deans meeting on October 11 and the All Department Chairs meeting is on October 14. Nothing is changing substantively this year in collaboration with the Faculty Senate. 5 Year PPR - ISU's policy ISUPP 4010 says "All continuing faculty will follow this process" The Board only requires tenured faculty. ISU is only doing "tenured." We'll follow the waiver until we get ISUPP 4010 policy revised. ISU is only requiring an updated CV. The Faculty Senate is on board with this and will be prioritized with FPPC. 3 Year Review and 5 year PPR are added to the TMS in lieu of an evaluation for that respective. An evaluative ranking is required for merit and based on that calendar review. 	Karen
