Planning continues for an environmental health and safety initiative connected to Earth Day along with the environmental summit. He also met with several operations and SUB leadership members to continue developing the proposed Game Pass program, which will allow students to receive one free monthly activity such as billiards, bowling, or a craft, redeemed with their Bengal ID card swipe similar to meal plan swipes. The first Wake Up Wednesday event took place today, with two more scheduled over the next two weeks. Regarding the ESports room, there are currently no plans for the space, and suggestions are welcome. Additionally, Brian Sagendorf, Vice President for Campus Operations, will be attending senate next week, on December 10th to present updates on the Shirley Sargent boardroom renovation.
