Senator Kissoon- Before a vote is called for the last person, it is necessary that ASISU have a discussion. **MOVE TO DISCUSSION FOR TEN MINUTES.** Kissoon/Kinzel. Unanimous. **MOTION CARRIED.** Senator Marshall- Sam Horsley was interviewed for the position of Deputy Elections Commissioner, as requested by President Schmidt, but the Rules and Appointments Committee have some concerns. Although this freshman wants to be involved, his application was incomplete. He failed to include a transcript, a resume, and did not even know for which position he was applying. Even though he dressed nice and spoke well, he was not prepared. Senator Stock agreed with Senator Marshall and noted that everyone else who applied were actually prepared. Senator Dhakal asked for point of clarification of how many applicants there were. Senator Marshall- Three, and the committee chose someone else. **MOVE TO YIELD THE TIME TO PRESIDENT SCHMIDT.** Bailey/Dhakal. Unanimous. **MOTION CARRIED.** President Schmidt- Sam approached him at the beginning of the semester asking how to get involved with ASISU. President Schmidt failed to tell him the details about the position and did not clarify the application process. His transcript was later received and his grades are good. He is a young kid, ready to learn, and senators are supposed to be mentors. President Schmidt said that he would like Sam to become President of ASISU one day and if he were allowed to vote, he would vote for Sam to be approved. Senator Alvarez asked for point of clarification. She asked if it's necessary to put this off again until next week if the majority were to vote no. Senator Marshall- It must go through the president first. Careful time should be taken to select the right person. Senator Kay asked if they have a specific candidate in mind. Senator Stock- Yes, but it must first be approved by President Schmidt. Senator Kissoon pointed out that the selection process shouldn't be based on feelings and the candidate should have some previous experience with clubs, etc. Senator Stock seconded Senator Kissoon's opinion and agrees with Logan. However, Sam is already involved with SAB and can reapply for an ASISU position another time. **MOVE TO YIELD THE TIME TO PRESIDENT SCHMIDT.** Kinzel/Kissoon. Unanimous. **MOTION CARRIED.** President Schmidt- This is a very low ASISU position and although he is involved with SAB, he is not getting paid. He is very supportive of all ISU events and has been very dependable. When President Schmidt was Finance Officer, he didn't know what he was doing and even as President, he doesn't know everything. It is important to give Sam a chance. Senator Lozano- It's awesome that freshmen want to get involved but that does not diminish the fact that Sam's application was incomplete. If ASISU were to approve him, then the application process would not be formal. Senator Bailey asked how many turns he had left after he yielded the time to President Schmidt. Senator Jewkes- Senator Bailey has one turn left. Senator Bailey- He appreciates the reasoning from everyone and a second interview may be conducted if needed. Senator Kay- **MOVE OUT OF DISCUSSION.** Kay/Bailey. Unanimous. **MOTION CARRIED. MOVE TO APPROVE SAM HORSLEY AS DEPUTY ELECTIONS COMMISSIONER.** Marshall/Alvarez. Roll call.
