Alumni Survey Results: Masters and PhD: Fall 2023

What follows is a brief overview of the results of our recent graduate follow up surveys: Alumni.

PhD Alumni Survey Data

1. Which of the following best describes what you do now?

100% of responses (N=8), indicated "Employed full-time as a counselor educator."

2. What is the percentage of workload delegated to teaching?

For those who responded (N = 8),

- 63% percent indicated "60%,"
- 13% chose "40%," and
- 13% chose 80%.

3. What is the percentage of workload delegated to supervising?

MCOUN Alumni Results

Results for the MCOUN graduates from 2022 and 2023.

Employment status:

Of those responding (N = 29),

- Employed full time as a professional counselor: 52%
- Employed part time as a professional counselor: 31%
- Employed, but not as a professional counselor: 10%
- Unemployed by choice: 3%
- Unemployed by lack of opportunity: 3%

For those employed, top three pathways to employment were:

- Internship site 36%
- 25% Other students/friends
- 14% Recruited by employer

- 41% responded "Moderately Agree," and
- 14% "Slightly Agree."
- 3. I developed knowledge related to understanding the nature and needs of persons at all

developmental levels and in multicultural contexts as it relates to the practice of counseling.

Of the MCOUN alumni that responded (N = 22),

- 32% responded "Strongly Agree," \
- 36% "Agree Slightly,"
- 18% "Moderately Agree,"
- 9% "Moderately Disagree," and
- 5% "Disagree Slightly."
- 4. I developed knowledge related to an understanding of career development theories and decision-making models, and related life factors as it relates to the practice of counseling.

Of the MCOUN alumni that responded (N = 22),

- 50% responded "Agree Slightly,"
- 18% "Strongly Agree,"
- 18% "Moderately Agree,"
- 9% "Disagree Slighlty," and
- 5% "Strongly Disagree."
- 5. I developed knowledge and skills relating to the practice of counseling in a multicultural society which included counseling theory, and essential interviewing and counseling skills.

Of the MCOUN alumni that responded (N = 22),

- 41% responded "Strongly Agree,"
- 36% responded "Moderately Agree,"
- 18% "Agree Slightly," and
- 5% "Strongly Disagree."
- 6. I developed theoretical and experiential understandings of group purpose, development, dynamics, theories, methods, skills, and other group approaches in a multicultural society.

Of the MCOUN alumni that responded (N = 22),

- 50% responded "Moderately Agree,"
- 23% responded "Strongly Agree,"
- 23% "Agree Slightly," and
- 5% "Strongly Disagree."
- 7. I developed an understanding of individual and group approaches to assessment and evaluation in a multicultural society.

Of the MCOUN alumni that responded (N = 22),

- 27% responded "Strongly Agree,"
- 27% responded "Agree Slightly,"
- 23% "Moderately Disagree,"
- 14% "Moderately Agree," and
- 9% Disagree Slightly."

8. I developed an understanding of research methods, statistical analysis, needs assessment, and program evaluation.

- 23% "Moderately Agree,"
