a. Academic Rank policy was accepted by faculty senate only 10 yes votes and the rest of the members abstained

a. Action Item 1: Definitions

ACTION- Stegner motioned to delete definition "D"

Byington seconded

Discussion ensued

Friendly amendment to change lettering reference on "B"

Motion passed with 9 yes's

b. Action Item 2: Grievable Events and Denial of Tenure

- i. Howe argued that state board policies
- ii. Several members noted that these policies forbid appeal of nonrenewal, but are silent on the appeal of tenure decusions themselves.

II.G.5.b.i, II.G.5.b.i, and II.G.5.c exclude denial of tenure from any appeal except for protected class discrimination

- 1. Rodriguez argued this is not, in fact, the case, and that these policies forbid appeal of nonrenewal, but are silent on the appeal of tenure decisions themselves
 - 2. Discussion ensued
- 3. Holland suggested adding a reference to the SBOE policy in this section rather than interpreting that policy's application to tenure

ACTION- Holland moved to table the item until the end of the meeting
