III. Report from Faculty Senate Meeting- August 29, 2022

- a. Senators were told that Grievance will have to be amended and re-approved due to the records retention clause
 - i. Administration is looking into the idea of hiring an official records retention administrator
- b. The standing appeals panel is still in the works for getting filled

- c. Academic Integrity Committee is in the works for getting formed
- d. Gender, Equity and Inclusion Committee has been proposed
 - i. This council will probably focus on Gender

IV. Report and Consultation with University Policy Manager, Libby Howe

- a. Two policies have been approved having to do with HIPPA
- b. Protection of Minors policy is in 30-day review
- c. General Council is still working on the Research Policies to ensure they are in compliance

V. Grievance Policy

- b. Forest- HR's response to what the list of documents is to be given to the Grievant/Respondent as well as training processes in place

- a. Status and processes once Legal Counsel has completed their efforts
 - i. Legal is still taking a look at these policies

VII. Dismissal For Cause Policy

- a. Lyle Castle- history on how documents have been processed in the past
 - i. In the past, the process was decentralized
 - 1. The records were stored by whomever was in charge of the process
 - ii. Downing said that Sagendorf (VP of Operations) said he does not feel HR should have the records but that they should be kept by Academic Affairs
- b. HR's response to training the appeals panel
 - i. Due process rights are whatever is in the policies
- c. Section III.G

d. Section III. H

ACTION- Roche motioned to approve this section

- e. Section IV. A
 - i. Howe commented that "Notification of Contemplated Action," is a very specific thing and should maybe not be used for this policy
 - ii. Doan provided language for this section
 - 1. Council discussed this language and performed wordsmithing

2. The following language was decided upon

"The University may opt to proceed directly to the processes outlined in section IV.B., forgoing Notification of Recommended Action if the recommendation of suspension or dismissal for adequate cause is due to a particularly egregious action(s) not performance related, including but not limited to sexual harassment, other forms of harassment prohibited by law, and criminality."

 - a. 10 working days was added

- 4. Section IV.B.2
 - a. The method of notification was discussed as per the idea of certified mail
