III. Report from University Policy Manager, Libby Howe

IV. ISUPP 4120 (Faculty Ethics)

- a. Statement about applicable laws added
- b. Wording of faculty "sharing" governance changed to "participating in shared" governance
- c. Student discipline falls under Student Affairs' purview, not the faculty's
- d. Faculty and student evaluation norms separated in policy
- e. Generalized harassment language so that it is not limited to protected class context
- f. Remaining Challenges:

- i. Evaluation Criteria
 - 1. Goal is to limit criteria for formal evaluation to professional activities, and prohibit penalties or rewards for arbitrary personal characteristics
 - 2. "Solely" complicates this language because some evaluation also involves, e.g., policy compliance
 - 3. T&P and PPR criteria details should reside in those policies, so this is meant as broad statement of principle
- ii. "Presumption of Innocence"
 - Goal is to ensure that faculty are not punished for allegations in the absence of evidence, but also make it clear that investigation is expected, and suspension may be warranted where justified by probable cause
 - 2. Presumption applies to final finding, not steps during investigation
- iii. Libby will bring these up with Provost and General Counsel
