  - ii. Discussion focused on the Introduction (I) and Responsibilities as Teachers (II.A.1-II.A.2).
  - iii. Council discussed challenge of writing a policy that is specific enough to meaningfully define violations, but not so restrictive as to expose faculty to formal ethics reprimand for poorly preparing one lecture
    - Opinions varied regarding the relative merits of "should" "shall" "must" and language describing faculty actions without these words
    - 2. Straw polls tentatively supported retaining conduct standards, but moving to a simplified structure dispensing with sub-bullet specifics
