INSTRUCTIONS: If you are a **graduate** student, you may be eligible to borrow through the Federal Direct Graduate PLUS (GradPLUS) Loan program. **You must have filed a Free Application for Federal Student Aid (FAFSA) before applying for this loan.**

Other important information:

- Applicants for the Federal GradPLUS Loan must not have an adverse credit history, as reported by a national credit reporting agency. Applicants with an adverse credit history may still qualify with an eligible co-signer.
- Repayment begins within 60 days after the last disbursement of the award year. There is no six-month grace period. Borrowers may request a deferment while enrolled at least half-time.

- Your GradPLUS eligibility is limited to your cost of attendance (the financial aid budget) minus any other financial aid you receive.
- **A GradPLUS Master Promissory Note must be completed and signed the first time you borrow.**
- **A GradEntrance Interview must be completed the first time you borrow before loan proceeds can be disbursed. Go to studentaid.gov.**
