Idaho State University TRIO Upward Bound Programs Summer Food Service Program Public Release

The ISU Upward Bound Programs are participating in the Summer Food Service Program (SFSP). The Upward Bound Programs have applied to the SFSP as a closed site residential camp. Students who will be entering 9th-12th grade are encouraged to apply to attend the Upward Bound Programs Summer Academy if they attend the following high schools: Aberdeen, American Falls, Blackfoot, Century, Firth, Highland, Idaho Falls, Pocatello, and Shelley. Advisors visit each high school weekly during the school year to work with current students and assist new applicants in joining the program. Eligibility is based on federal regulations regarding parent education and income. The Upward Bound Programs are free to participants and 100% funded by the U.S. Department of Education.

Meals will be provided free of charge to all Upward Bound participants attending the 2023 Summer Academy. The SFSP will be used to pay for meals for eligible participants who must meet income guidelines for reduced-price meals in the National School Lunch Program. Income guidelines by family size are included on the previous page.

Meals will be provided at the Tuner Dining Commons at 64 Memorial Drive, Pocatello, ID 83209. The dates for meals through the Summer Academy are weekdays June 20-July 28. Breakfast will be provided Monday-Friday from 7:45am-8:30am. Lunch will be provided Monday-Friday from 11:45am-1:00pm. Dinner will be provided Monday-Thursday from 5:00pm-6:30pm.
